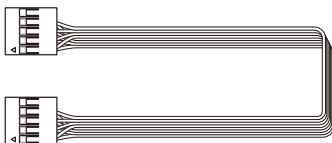

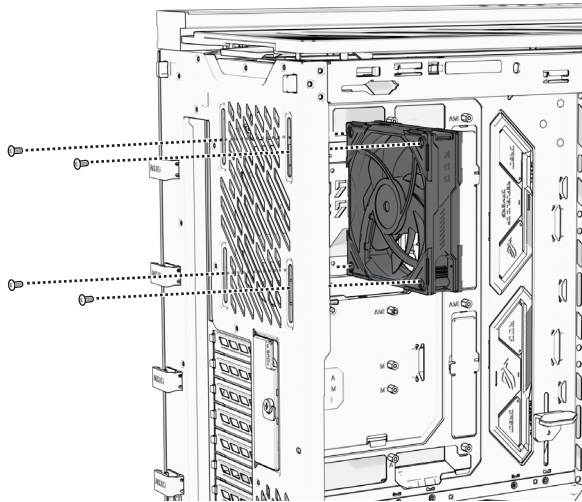


Daisy-chain configuration

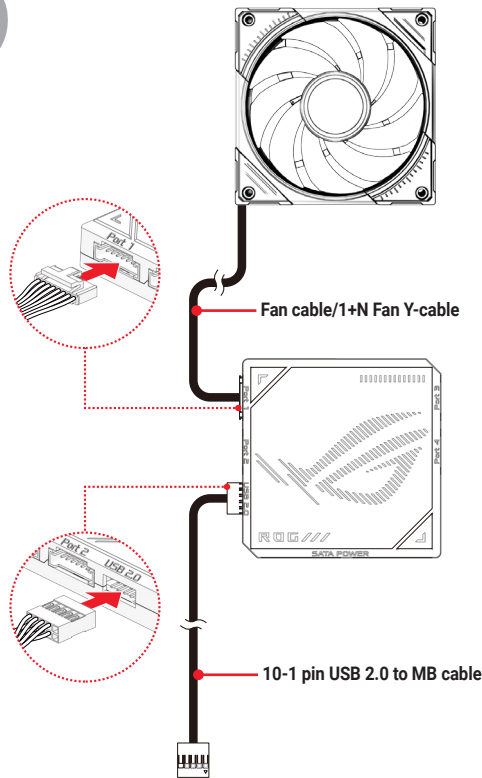

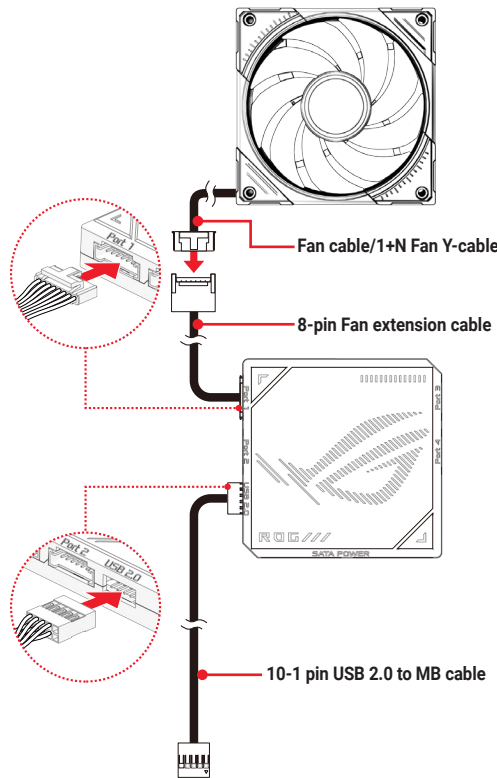
NOTE: Ensure the fans are all installed in the same orientation.

Without 8-pin Fan extension cable



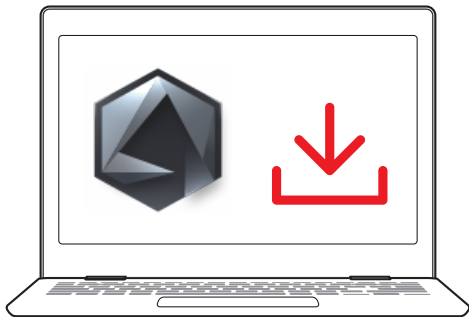
With 8-pin Fan extension cable



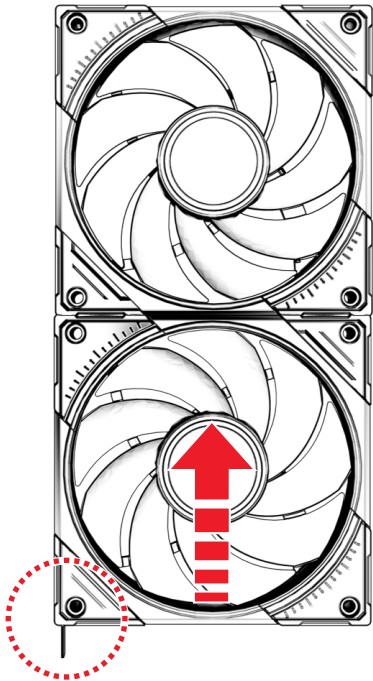
